The number of shares reported in the Original Filing did not include restricted stock grants of 51,000 shares to certain employees granted on December 20, 2017, making the corrected number of outstanding shares of Common Stock as of December 22, 2017 equal to 3,975,109 shares. In addition, the Company's definitive proxy statement incorporated by reference in Part III of the Original Filing will include disclosure of delinquent filers pursuant to Item 405 of Regulation S-K.

Except as described above, no other changes have been made to the Original Filing and this Amendment No. 1 is not intended to and does not update or modify any other information presented in the Original Filing, including with respect to events occurring subsequent to the original December 22, 2017 filing date of the Original Filing.
